3. The Advocate shall make a note of all the cases of Primary and Secondary Education Department and Karnataka Secondary School Examination Board to which he/she

is attached and follow up all the cases pending before the Honorable High Court and KAT from time to time.

4. The advocates maintain register of the cases and their status for review from time to time.
5. The Advocate shall get necessary records, para wise remarks, filing of statement of objections and filing of appeals and other assistance required by Law officer from the Department for effectively defending the cases.
6. The Advocate shall not argue/plead before the Courts in the cases filed against the Primary and Secondary Education Department.
7. The Advocate shall render assistance to the Advocate General's establishment as and when called for and coordinate in terms of Advocate General/s directions.
8. The Advocate shall maintain utmost efficiently, secrecy and integrity in discharge of their duties.
9. The Advocates shall strictly follow the instruction of the Law Officer.
10. The appointment of Advocate is purely on consolidated remuneration and can be terminated at any time without prior notice.
