3. Quoted Price:

- (a) The bidder shall quote for items in the format attached;
- (b) All duties, taxes and other levies payable by the bidder (including Sales tax on the finished goods) shall be included in the item rate.
- (c) The rates quoted for each item shall be fixed for the duration of the contract and shall not be subject to any adjustment.
- (d) A rate for supply of partial quantity of an item is not acceptable.
- (e) Corrections if any shall be made by crossing out, initialling, dating and rewriting.
- (f) Cable or Facsimile quotations are not acceptable.
- (g) Security deposit of 5% of contract value shall be paid by bank guarantee/D.D/Challan to board. (Punjab National bank, Malleswaram Branch A/C No:1261000109019723 IFSC Code:PUNB0126100)
- (h) Agreement shall be executed on e-stamp paper of rupees 100/- in favor of the Director(exams) K.S.E.A.B Bengaluru. in prescribed format. (Format will provide with LOA)

4. Each bidder must submit only one quotation.

5. Validity of quotations:

The quotation shall remain valid for a period not less than 30 days after the deadline fixed for submission of quotations.

6. Evaluation of quotations:

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e., which are properly signed, and conform to the terms and conditions and specifications in the following manner:

- a. The evaluation will be done including the Sales tax. If the bidder has not included the Sales tax in his quotation for the item rate, and has also not indicated the rate of Sales tax applicable, the quoted rate will be treated as though it is inclusive of the Sales tax and no extra payment for Sales tax will be made;
- b. The evaluation would be done for all the items put together. The items for which no rates have been quoted would be treated as zero and the total amount would be computed accordingly. The bidder who has quoted for partial quantity of any one or more item(s) would be treated as non-responsive. Purchaser will award the contract to the responsive bidder, whose total cost for all the items put together is the lowest.

7. Award of contract:

- a. The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as per Para 5(b) above and as per preference mentioned in the Government Order No.: SWD 34BCA 2004, Bangalore, dated 10.03.2005.
- b. Reservation ratio mentioned in the Government Order No.: SWD 34BCA 2004, Bangalore, dated 10.03.2005 is as below.




- c. The Purchaser reserves the right at the time of contract award to increase or decrease the quantities of any or all of the items indicated in Para 1 above by 25% without any change in the unit price or any other terms and conditions.
- d. The Purchaser prior to the expiration of the quotation validity period will notify the bidder whose quotation is accepted of the award of contract. The terms of the accepted offer shall be incorporated in the Purchase order.
- e. Normal commercial warranty/guarantee shall be applicable to the supplied goods;
- f. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotations at any time prior to the award of the contract.

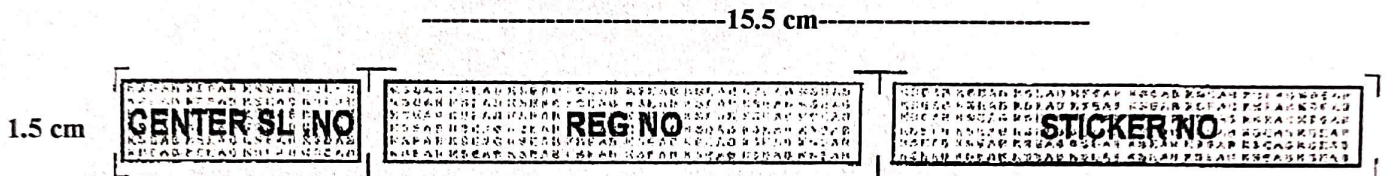
