Bids are invited by The Karnataka Secondary Education Examination Board having its office at 6th Cross, Malleswaram, Bengaluru-560 003, represented by its Director, Exams, from eligible bidders for purchase and disposal of “OMR And CNR Formats” pertaining to 2021 SSLC Exam through e-Auctions. The interested bidders may inspect the above said items, before quoting their bid in e-Auction platform. No dispute shall be entertained after finalization of the e-Auction.

1. ELIGIBILITY CRITERIA: -

The applicant

- shall be a proprietary / partnership firm / Pvt Ltd Company / Public Ltd Company Or Re-pulping Industry.
- shall be an Income Tax Assesses during the last three financial years viz 2017-18, 2018-19 and 2019-20 i.e., Assessment years 2018-19, 2019-20 and 2020-21 respectively.
- should have an average turnover of at least Rs.20.00 lakhs in the past three financial years viz. 2017-18, 2018-19 and 2019-20
- should possess GST NUMBER obtained from Department of Commercial Tax, Government of Karnataka.
- should have the experience of disposal of confidential paper in the last three years.

3. e- AUCTION SALE TERMS AND CONDITIONS:

- i) CNR and OMR formats stored in KSEEB go downs not packed. Material will be permitted to be lifted against full payment of sale value and all statutory taxes on "As is where is basis"
- ii) **The materials are sold in a single lot 'As is where is basis' only. Board is not responsible for any variations/difference in the weight of the material in any way. Therefore, the bidder is at liberty to inspect all the material stored in the Board. No objection in this regard shall be acceptable by the Board after the Bidding in anyway.**
- iii) Sale will be made as per the sale terms and conditions of the Department and which are not negotiable.
- iv) The successful bidder should lift the material within 15 working days from the date of issue of delivery orders by the KSEEB.
- v) Lifting of material should start immediately after the issue of Work order.
- vi) **The TIA reserves the right to issue the delivery and for lifting the material to the successful bidder.**
- vii) The Auctioned material being very confidential in nature, the successful bidder should dispose the material by re-pulping in bulk only without a single booklet/portion of the booklet being made available in public under any circumstances.

4. EARNEST MONEY DEPOSIT [EMD]:-

- i) EMD needs to be paid by the bidder through e-Auction platform as mentioned in Para 2 above.
- ii) The refund of EMD for unsuccessful bidders will be made after entering into an agreement with the successful bidder.
- iii) The earnest money deposit may be forfeited If a Bidder :
 - a) Withdraws its Bid during the period of bid validity period or
 - b) In case of successful bidder fails to sign the Contact and furnish the performance security within due date.

5. SALE VALUE & PERFORMANCE SECURITY

- i) The EMD of the successful bidder shall be retained as performance security. The variable amount to 5% performance security of the material value, Bid amount & Tax amount shall be payable by the successful bidder through Demand Draft from any Nationalized Bank only drawn in favor of "The Director Exams KSEEB Bengaluru" within 7days of the receipt of notification of award of contract from the KSEEB & 5% performance security shall be returned after the satisfactory completion of all the obligations under the e-auction.

- ii) The successful bidder shall deposit the sale value, along with performance Security through Demand Draft from any Nationalized Bank only, drawn in favor of "The Director - Exams, KSEEB, Bengaluru or through RTGS to K.S.E.E Board Bank Account within 07(seven) days of the receipt of the "Notification of Award". If the bidder fails to deposit the Sale Value within stipulated time, K.S.E.E Board will forfeit the EMD/Performance Security along with Blacklisting the Bidder. In such events, K.S.E.E.Board shall award the bid to the next highest evaluated Bidder and so on until the completion of "Notification of Award" process within the validity period of e-auction or invite a new auction.

6. UPLOADING OF BIDDER'S CREDENTIALS / ELIGIBILITY DOCUMENTS

- i) The bidder shall upload the following documents in e-Auction Platform for the purpose of Pre-Qualification to e-Auctions.
- ii) Certificate confirming proprietary firm (from Bank or Chartered Accountant) / partnership firm (Partnership Deed copy) / private limited company / public limited company (Memorandum & Articles of Association)
- iii) Income Tax Assessed for the last three financial year's viz 2017-18, 2018-19 and 2019-20 Copies of Assessment Order / copy of Returns filed.
- iv) Annual Turnover of at least **Rs.20.00** lakhs on an average in the past three years viz. 2017-18, 2018-19 and 2019-20 The financial Turn over documents shall be verified & attested by registered statutory Accountant/Auditor.
- v) Copies of GST Registration Certificates.
- vi) PAN Card copy.
- vii) Should have the experience of disposal of confidential paper in the last two years.
- viii) Bidder Details in Annexure-1 of this Document and other certificates as per annexure II III,IV,V & VI.
- ix) **The bidder is eligible only if an UNDERTAKING AS PER ANNEXURE-II is uploaded certifying the maintenance of confidentiality of the material and transportation of material to the mill for Re-pulping only.**

7. SUBMISSION OF ORIGINAL DOCUMENTS: -

- i) The bidder shall submit the originals of the uploaded documents in case needed for verification, at The Karnataka Secondary Education Examination Board, 6th Cross, Malleswaram, Bengaluru – 560 003 at the time of Pre-Qualification scrutiny.

8. PRE-QUALIFICATION SCRUTINY

- i) The Pre-Qualification Bids will be scrutinized by KSEEB on 11.03.2022 The Pre-Qualification documents shall be evaluated by the Auction Scrutiny Committee constituted by the Director, KSEEB for confirming the eligibility criteria of the applicants. Thereafter, the pre-qualified bidders eligible for participation in e-Auctions would be informed through e-Auction Platform.
- ii) KSEEB reserves the right to reject all / any of the bids without assigning any reasons whatsoever.

9. CRITERIA TO CONSIDER BIDS INVITED THROUGH e-AUCTION: -

- i) "Printed booklets" is a single lot on "As is where is basis" irrespective of approximate quantity mentioned in the e-auction document and no part sale of quantity of the lot will be considered. The highest bidder for the entire lot is considered as the successful bidder and the bid will be awarded to such bidder subject to the condition mentioned under clause No:5, ii.
- ii) KSEEB reserves the right to reject all / any of the bids without assigning any reasons whatsoever.

10. LIFTING OF MATERIAL:

- i) The successful bidder/ bidders shall lift and transport the material at their own cost within 15(Fifteen) working days during office hours from the date of issue of Work order.
- ii) **The TIA reserves the right to issue the delivery and for lifting the material to the successful bidder.**

11. RESERVE PRICE: *

- iii) The KSEEB has fixed a Reserve Price of Rs.7,70,130/- (Rs. Seven Lakh seventy thousand one hundred and thirty only) excluding all applicable taxes for the entire lot that includes Approximate 40.78 tons of OMR And CNR Formats. The bidder shall quote a price over and above the Reserve Price.

Note :“ Reserve Price” is the minimum basic price of the material fixed by KSEEB as per prevailing market condition. Which excludes applicable taxes, Rates quoted Equal to or Less than the reserve price will not be accepted by the e-auction platform.

12. BID PRICE:-

- i) The incremental increase in a bid is fixed as **Rs.5,000/-** for “Printed booklets” and multiples thereof. Bids equal to or less than the reserve price will not be accepted by e-Auction platform of Government of Karnataka. The incremental bids quoted by the bidders are exclusive of all statutory taxes.

13. BID INCREMENT:

- i) The maximum incremental price is kept at 10 times the bid increment. The bid increment is the minimum increase amount over the last submitted price. So, any bidder can bid in multiple of Rs.5,000/- in per bidding for “OMR And CNR Formats OF 2021 S.S.L.C. EXAMS on ‘As is where is basis’ and multiples thereof.

14. DELTA TIME;

- i) Delta Time for sale of “OMR And CNR Formats” OF 2021S.S.L.C. Exams on ‘AS IS WHERE IS BASIS” is set at 5 minutes. 5 minutes extension is given when any bidder submits bid within the delta time before the scheduled time of closure of e-Auctions. If any bid submitted between 12.55 and 1.00 pm will extend the closure of e-Auctions by 5 minutes from the last submitted time and hence continues.

15. SALE AWARD:

- i) The successful bidder before lifting the material shall remit the full value of material (Bid amount + TCS Amount at the prevailing rate calculated on bid amount) and agreement should be done within seven days from the date of receiving the Letter of acceptance. Payment shall be made only **through Demand Draft from any Nationalized Bank only, drawn in favor of “The Director-Exams, KSEEB, Bengaluru or through RTGS to K.S.E.E Board Bank Account”**. Also, the successful bidder has to remit the Sales Tax/GST under prevailing rate to the competent GST authority under ‘Reverse charge basis by the recipient’ as per the Notification No: 4/2017-Central Tax (Rate) New Delhi, the 28th June, 2017 and amendment Notification No: 36 /2017-Central Tax (Rate) New Delhi, the 13th October, 2017 to the same, issued by Govt of India, Finance department.

16. FORCE MAJEURE CLAUSE: -

- i) In case, the contract could not be fulfilled / cancelled / terminated for any reason arising out of the laws//regulations / restrictions governing natural calamities, war/ hostility, military operation of any character, civil commotions, sabotage, quarantine restriction, acts of Government embargoes, the successful bidder shall not be entitled for any compensation.

17. ARBITRATION: -

- i) Dispute that may arise between the parties, shall be settled through mutual discussion in good faith. The Director, KSEEB or his designated nominee shall be the sole Arbitrator for the purpose.

18. NON ASSIGNABILITY: -

- i) The Sale Award / Letter of Intent issued to the successful bidder is not transferable or assignable in whatsoever manner. The awardee shall remit value of the material and lift the allotted material himself by following the due procedure prescribed. KSEEB will not entertain any third-party nominee / assignee in what so ever manner on behalf of the awardee.

19. TERMINATION OF THE AGREEMENT: -

- i) In the event of any breach of any of the tender terms and conditions by the successful bidder and of the sale award or against the interest of The KSEEB shall be free to cancel the Sale Award / Delivery Order, but without prejudice to the claims of the KSEEB. The successful bidder shall have no claim against The KSEEB and the decision of the Director, KSEEB in this regard shall be final.
- ii) If the successful bidder does not lift the material within the specified period/extended period either if any in part or in full, Rs.10,000/- penalty per day will be levied for 10 days of delay, Performance security amount will be forfeited and lifting of materials will not be allowed thereafter.

20. PERIOD OF SALE: -


- i) The allotted quantity shall be lifted within stipulated period (15 working days) from the date of issue of delivery order or the extended period as notified by the KSEEB. In the event of failure to lift the material, within the originally allowed or extended time as the case may be, penalty will be levied as per section 19(ii).
- ii) KSEEB will have the powers to extend the delivery period due to unforeseen circumstances at its discretion.
- iii) The responsibility of KSEEB ends once the material is made available to the successful bidder.

21. COMPENSATION TOWARDS NEGLIGENT ACTIONS/DAMAGES AT THE GODOWN: -

- i) Successful bidder / Sale awardee shall be responsible for any claims arising out of negligent actions/ damages on the part of sale awardee on any property belonging to the Board and to their personnel, or in an accident involving any personnel or labour, during loading, transportation and unloading.
